A. Call to Order and Adoption of the Agenda

The meeting was called to order at 5:37pm.

B. Introductions

C. Presentations to Council

(10 minutes, 5 minutes for questions)

- The Intersectional Gender Based Violence and Aboriginal Stereotypes Task Force, Dr. Louise Cowin, VP Students
- The report written by The Intersectional Gender Based Violence and Aboriginal Stereotypes Task Force will make a series of recommendations including policy changes to ensure that there are consequences for actions.
- Recommended initiatives will support the university in having the authority to take action.
- There will be a focus on the promotion of Equality and Diversity at UBC.
 Emphasis will be placed on Orientation and building relationships with student organizations to ensure the expectations of UBC are clear and understood by all involved in planning and participating in Orientation activities
- There are 14 recommendations in total with the report being available online.
- Consultations will be held to gather student feedback and suggestions.
- The report will be presented to President Toope for approval.
- The report was written with undergraduate students in mind however, it is relevant to all GSS students including graduates in terms of the policies, protocols and the message that the report hopes to achieve.
- There has been collaborations with other universities and specific departments (Engineering) to initiate change.
- The Campus Safety Working Group, Barry Eccleton, Director, Campus Security
- The Campus Safety Working Group is comprised of students, faculty and staff.
- Recommendations made include; the continued use of cameras at main entrances and the bus loops, the promotion of safety awareness, anti-bullying, and anti-sexual harassment practices including new staff orientation.

- Campus Security will continue to strengthen their relationship with the RCMP and as well as promote closer working relations between the attachment and individual departments
- In addition to the continued use of emergency phones, Campus Security will investigate the use and implementation of other communication tools
- It was recommended that there should be improved lighting campus-wide and an assessment of the landscape
- The report is currently available online for consultation
- The RCMP have reviewed and are in support the report's recommendations
- After the occurrence of a series of sexual harassments last year, the number of security staff was increased however this is not a recommendation in the report but could be made by students as part of the consultation process.
- Sexual assaults or any criminal acts are referred to the RCMP
- The RCMP offers a range of victim services as does UBC
- Information is shared between the RCMP and University about the nature of incidents (personal information is kept confidential).
- Graduate Student Advising Interactions Rebecca Trainor, Student Academic Services
- The Faculty of Graduate and Postdoctoral Studies is considering the implementation of an online advising management system (OAMS). This is an online database that would allow for improved record keeping for graduate advisory staff.
 - There are two levels of access; open share and limited share. Limited share can only be viewed by a small number of staff at the Office of the Dean (advisory staff)
- This would not be available campus wide, but only to relevant departments and departments who choose to use the system
- The system could also be used to better understand students issues and how these might be addressed, i.e. trends, consistent issues at a particular department
- A student could request that their information be kept off the record however there are certain types of information that advisors are required to report. There would always be a consultation with students about how the system works and what type of information would be recorded.
- If a student does not wish to be identified they can obtain confidential information via email, in-person, or phone a student is not required to identify themselves
- There would be full disclosure in that advisors would refer students to information on the website about the system
- It was asked whether the system could be used against a student; in establishing a history of certain or repeated behaviours? The response was that the system is not intended to put students at a disadvantage but rather, to improve record keeping and potentially provide more timely outcomes in student cases.
- Students would not have access to this system but can be notified via email of all correspondence relating to them.
- Records are retained for 3 5 years. Requests for information about who has accessed student records must be made to the Dean's Office.
- The system will be a way to streamline information; i.e. between Graduate Studies and ESP and will allow for effective collection of information.
- The Canadian Alliance of Student Associations Jon Champagne, CASA

- The Canadian Alliance of Student Associations (CASA) is an alliance of 24 student associations and student unions from across Canada
- A main area of focus has been lobbying the federal government for increased financial aid for BC students (the federal government provides 60 per cent of provincial student loan funds) in the form of Loans and Grants, Direct Federal Transfers and Research Funding
- CASA is actively involved in Advocacy in the form of media engagement, partnerships, consultations, local outreach, campaigns, meetings and research
- Results of CASA efforts include multiple entry visas for international students, vehicle exemption in asset assessment, open access reforms, and no significant federal cuts to financial aid since 1995.
- BIRT the agenda be adopted as amended (7:25pm) MOVER; Eric Becklin, SECONDER; Colúm Connolly PASSES
- **Report on Executive Performance** *Jeff Abeysekera, Executive Oversight Committee*
- In 2014, executive reviews will take place twice instead of three times a year due to a restructuring of the process.
- A review took place in November. Executives were assessed by councillors and GSS staff.
- Meetings were held with each Executive to provide feedback.
- The Group Evaluation assessed the Executive on planning, communication, conflict management, effort, reliability and collaboration (there were 12 responses in total).
- The Executive scored highest in effort.
- Collaboration and communication received mixed reviews.
- Areas for improvement included conflict management, collaboration, communicating their progress, transparency, and reporting.
- It was recommended that the Executive focus on establishing combined goals rather than achieving individual goals.
- It was suggested that there be consequences for executives who do not adequately fulfil the requirements of their role
- It was recommended that more training be provided to incoming Executives
- In terms of objectives versus progress; the voice campaign was cancelled due to lack of interest, the website was delayed, and the GSS informative videos has been postponed for the new executive to complete.
- The next review will take place in March.
- There will also be a review and restructuring of the Executive Oversight process.
- **2014 GSS Elections Report**, Gabby Badica, Chief Electoral Officer
- There was an increase in voter participation from 5 7 per cent to 9.7 per cent
- The coordination of the GSS Elections with the AMS Elections is likely to have played a significant role in increased voter participation
- Other factors include increased communication via email, postering, campaign videos, the GSO Caucus, and social media.
- It is recommended that the GSS use Simply Vote as opposed to WebVote, as it is more user-friendly and allows for a summary of each candidate

- It is also recommended that the GSS continue to conduct their elections at the same time as the AMS elections
- The Elections Committee will continue to discuss and review proposed code changes including participation in the all-candidates meeting and not permitting slates
- A small number of Facebook ads were purchased at the end of the campaign period. Inviting friends via Facebook was also effective.
