Group responsible: Janet Mee, Director, Centre for Accessibility **Presentation time:** 30 minutes (15min presentation + 15min Q&A)

Presentation description: Update on Policy 73; review of key changes to Policy 73; and overview of commitment to universal design

Ty: Graduate students belong to GPS and our respective faculties. So who will you work with ?

Janet: Both – we rely on them to be the common admin group, but the department

will have the expertise to put recommendations in place.

Alexa: Do you have an adviser that specializes in grad students needs, particularly around exam time? What about TAs – if your contract ends and there is an exam later, will the TA be required to grade it?

Janet: We do not have an advisor currently that specializes in grad students. All our staff is well trained and able to respond to grad students needs. 14% of the students we see are grad students, and a lot of them come from different faculties. We have the expertise, but we don't have it specialized. In regards to your second question: oftentimes the duty to accommodate falls within the individual ... the university will not consider it undue hardship for the individual to do such a thing. One of the big challenges is the number of sessional instructors, number of TAs ... there is a disproportionate burden based on those staff.

Sara: Thank you so much – do students still need to go through the Center for Accessibility? They still feel marginalized and express frustration about it.

Janet: Two perspectives on this question. The first one is administrative: the policy does require that students provide documentation that certifies their disability. We do recognize that some students do not agree with this process and find it an additional burden. If we could do things differently, we would love to have this conversation. In the absence of this information, it is very difficult to determine what would work in terms of an accommodation. It is a requirement and it helps us do our work.

Kate: Could you give an example of what would be considered an essential requirement for a program?

Janet: Can I use case law? The case that led to the language in the policy. It is about a firefighter working in the interior for the Ministry of Environment. The Ministry had a process to determine what candidates would be good for the job, and namely those who could run 1 mile in 8 mins. However, they also applied that standard to people, who were already successfully working as firefighters. One female employee failed the test and the Province terminated her from her job. The Supreme Court reversed the decision. And there are many more such examples.

Similarly, in medicine being on-call was part of the job. We would argue that on-call gave you many skills – such as working alone, being efficient, etc.

Maria: Besides knowing all this, will this change of policy change what we do as Councillors?

Janet: Yes and no – you can play an advocacy role for a student who was not getting proper accommodation. This is a large institution so the more people know about it the better the advocacy.

Nicolas: If we have an issue around disability should we refer this to your office rather than working it out ourselves?

Conny: The answer is yes.

Teesha: You mentioned that in some cases external experts are called. Where do they

come from?

Janet: Depending on the dispute the experts will differ. So we will call experts in human rights legislation, who will give advice on the process to go through a human rights legislation issue. We will ensure that most often there are external legal experts.

Matter #2

Group responsible: Elections committee

Objective: Summarize current progress of 2019 GSS Executive Elections

Summary: Nomination period has now ended. We have one candidate for President, one candidate for VP Students, four for VP University and Academic Affairs, and three for VP External. Campaigning period starts on Feb 19 until the end of Elections. The debates will be held on Tuesday Feb 26 (BC Cancer Research Centre) and Thursday Feb 28 (St John College). Voting starts March 4th to March 15th.

Alexa: Why are senators not included in the election blurb?

Jun: According to the Academic Governance Officer because we have two positions and two candidates, there will be no official elections and they will be automatically elected. Their names will appear on the list.

Maria: But this is not the case for the one candidate we have for President and the other for VP Students?

Conny: No, it is not as one is provincial law, the other is GSS.

Pouya: Campaigning can be until the day of election or not ...?

Nicolas: Campaigning can continue until the end of voting according to Chief Electoral Officer.

Matter #3 - President's Announcements

3.1. GSS Logo Update:

In Jan 2019 Susan Point, a Musqueam artist of national repute, accepted the invitation extended by GSS soliciting a First nation artist to produce a logo for the Society. Susan Point has produced the bespoke logo design for the GSS (Please see UBC graduate logo). The initial design specifies design justification and rationale by Susan. A contract has been executed and the GSS expects the final version in March 2019. Ben Hill, who has been in the lead of the project, will work with Susan closely to ensure the design meets all technical specifications before it is delivered in March.

Jun: What is the expected timeline for implementation of the logo? I really like it and hope to be given updates about the final color.

John: We expect to have the final before March Council. The color is a technicality as Ben Hill and the team are working on choosing the colors. You will have the option to see it before the date.

Ty: John, thank you so much for doing this – we have been waiting for two years. After we have the logo, we will need to do new merchandise. Have you considered the budget implications?

John: Yes. There is budget for it.

3.2. GSS/AMS Health and Dental Committee meeting: 24th January 2018

- Please see minutes attached.
- Highlights:
 - * Psychology Coverage: In Oct 2018 the committee meant to discuss premium increases of \$3.12 (to be verified) per student per annum to increase coverage from \$300 to \$500.
 - * 5% increase in premium is being proposed for 2018/2019 session to keep up with inflationary coverage costs.
 - * Health and Dental Survey questionnaire, administered by Studentcare was presented and approved by the committee.

Nicolas: Could the committee prepare a breakdown on how the total fee is constructed? We get a recommendation about systematically raising the total fee, but we don't know the particulars.

John: The increase is inflationary. I will soon receive the breakdown and send it to you.

Nicolas: They will always recommend an increase. My thought is that there may be services we are not using and getting rid of them may decrease the inflationary pressure. So this is why I want the breakdown.

Conny: From my time, 5% is not even enough.

Maria: Do we have a say on it?

John: Once the committee passes it, it comes to GSS and AMS Council.

Jun: Is this cost increase going to be done through a referendum – you mentioned a referendum when you were speaking?

John: The cap increase has to go through the two Councils and this is what I meant by a referendum.

Kate: When will this come to a vote?

John: March Council.

Tayo: 5% for just inflation is high. In the last two years, inflation has been about 2% – I just checked.

John: We are shooting for the limit, the reason is there is push to increase psychology services from \$3 to \$5 per student. The premium has to be absorbed.

Alexa: Is this different from the Empower Me discussion. Is there any talk of combining the two programs?

John: Empower Me is a different service altogether – it does not give clinical psychological services. It does not satisfy us. The plan is to give this service to both our societies.

Kate: Empower Me does provide referrals to limited registered counselling.

John: Empower Me could eventually recommend clinical psychology, but it is not the immediate service. The psychology service will give up to 5 clinical visits per person. So separating the two is the best.

Rahaf: Can these students be referred to a psychiatrist through their GP? Do they need the extra coverage or is it already covered?

Nevena: This is more of a response – a psychiatrist referral can take upwards of 3–4 months, whereas a psychologist can give a service within a week. So this coverage is essential for providing equity. Also the training is very different. Giving breath of options is best.

Theresa: I am from the psychology department. A psychiatrist is someone, who is trained in medicine, so treatment is very different. It is not a lot of money as the service is very expensive.

Alexa: UBC also has counselling services on campus. Have you advocated on more UBC run counselling services?

Jeanie: UBC is thinking about restructuring the way it does mental health. UBC doesn't have buildings for hiring more counsellors. So there is some capital planning for the long-term. They are trying to tie the different units together and re-structure them.

Matter #4: Executive Committee Updates

4.1. GSS Executive/VPS office meeting: 23rd January 2019

- Deep dive into GSS Student satisfaction survey presented at Nov 2018 meeting. Outcome was selecting 5 priorities for the year (see attached GSS Priority Framework Template for details).
- The committee is in the process of developing actions to populate the framework and inviting input from Councillors.
- VPS office shared a policy proposal draft on Policy V-130 Content and Distribution of Course Syllabi, made to the Senate (see attached).
- Information shared by VPS on Child Care Expansion Project (please see attachment)
- Possible varsity game event for graduate students discussed GSS VPS organized a 30-ticket graduate student group attendance on February 8th Thunderstruck game.

Arezoo: What about GSS autonomy? After Life Center is built will it belong to GSS? **John**: Yes, it is clear that the ownership will remain with GSS. We are working on signing a document.

4.2. GSS Exec Comm/VPS/G+PS meeting on Graduate Life Center: 28th January 2019

- Agenda of the meeting is to plan next steps of action after the approval of the project proposal and inclusion in the UBC Strat Plan.
- Project will begin along at least two parallel paths: (i) identification of programming needs/desires and (ii) building needs. A building assessment will need to be done initially, beyond what was done for the VFA and recent projects (Sauder, SPO). Estimated to cost the order of \$30–50K (or more). The need for seismic upgrading will be part of that. Funding for necessary seismic upgrading would likely come from a separate source (central UBC, city...).
- Gaining Executive 1 approval was recommended (by Interim VPS), to ensure recognition and support of the concept. It could include an ask for the building assessment costs (Please see GLC Vision attached for Exec 1 draft).

 (i) programming
 - An individual needs to be hired (as per proposal) to coordinate the
 consultations on programming/purpose/interest. This person should have
 experience in graduate student life, and ideally also experience in running a
 student center. One possibility is to have the new 'community liaison
 coordinator' position in VP-S tasked with this job. Otherwise, we should write a
 JD for a one-year contract and advertise (and/or identify someone)
 - To help in the preparation for Exec 1 approval and also the consultations, we created a short (no more than 3 page) 'vision document' about the big picture. To include the top 3-5 things the university needs to better support graduate students in this domain, and some big ideas of what a GLC could be; mainly a fleshing out of the material we've been circulating. We should also be initially identifying the groups to be consulted, to finalize when the new hire is on board.
 - Eventually, consultations will identify interests and 'infrastructure intervention boundaries'. There may or may not be time to include targeted questions on the upcoming GSS survey.

b. Matter #1

Group responsible: Elections committee

Proposed objective: Suspend Policy 12.4.5 for 2019 GSS Executive Election

WHEREAS Policy 12.4.5 reads: "There shall be no campaigning within ten meters of: (a) the polling booth when polls are open, in the case of paper ballots, and (b) any member known to be using a device currently logged in to the electronic, in the case of an electronic voting system."

WHEREAS it is difficult for candidates to monitor individual smartphones which may or may not currently logged in to electronic voting.

WHEREAS the restriction may be interpreted as "do not campaign near anyone who has a smartphone".

WHEREAS Policy 12.4.13 has already specified: "Candidates shall not in any way force or dishonestly influence a member into making a voting decision in any way."

BIRT the GSS Council, by special resolution, suspends part (b) of Policy 12.4.5 (There shall be no campaigning within ten meters of: (b) any members known to be using a device currently logged in to the electronic voting, in the case of an electronic voting system.) from February 21 to March 15, 2019.

MOVER: Elections Committee SECONDER: Theresa Pauly

Kate: I would like to point out that any person with a smart phone could potentially shut down campaigning simply by walking close to the campaign.

Arash: How does this make this impossible to do?

Jun: Technically speaking we have lack of enforcement power. The only thing we can do is to disqualify the person.

Solomon: Do you have mechanisms to check if people do not break this law?

Jun: No mechanisms except for grad student reporting that they are called to vote in a certain way.

Solomon: I think we need to improve this matter and put measures in place.

Kate: The current policy to prohibit campaigning within 10m means two things: 1. The intent of the policy, a candidate cannot go to someone who is voting and tell them vote for me; this is also prohibited by Policy 12.4.13 against dishonest influence. 2.

Proposed objective: Suspend Policy 12.4.6 for 2019 GSS Executive Election

WHEREAS Policy 12.4.6 reads "Candidates may not use Society or any email distribution lists administered by UBC, its faculties, or Departments during their campaign.

WHEREAS UBC Policy does not disallow campaigning using email distribution list. **WHEREAS** Elections committee intends to increase the voter turnout by encouraging candidates to campaign through email campaigns.

WHEREAS email distribution lists of individual departments can be accessed by request to the departments' graduate secretaries.

WHEREAS Elections committee does not have the resource to monitor the use of individual departments' email distribution list.

BIRT the GSS Council, by special resolution, suspends second half of Policy 12.4.6 (... or any email distribution lists administered by UBC, its Faculties, or Departments during their campaign) from February 21 to March 15, 2019 to allow candidates to use their departments' or faculties' email distribution lists to introduce themselves and to remind fellow graduate students to vote.

BIFRT notwithstanding the suspension, Council clarifies that candidates are disallowed from using Society's email distribution list for GSS Executive Elections campaigning.

I am sorry that I wont be able to attend today's meeting, and thank Jun for reading my comments. I believe the society should not suspend section 12.4.6 from the Policy Manual due to the following rationales. First off, I believe the use of faculty/departmental email lists would clash with Policy 97 "Conflict of Interest and Conflict of Commitment". The policy states that no one may use "information that is acquired as a result of his or her relationship with the University and not in the public domain for Non-University Activities". The term "Non-University Activities" refers to anything that falls outside a person's official duties at UBC, which I would argue clearly includes campaign messages intended to solicit potential voters. Accordingly, UBC contact info should not be used for this purpose. I also have serious concerns about how this could impact our ability to administer a fair election. When students approach faculty/departmental staff to have their campaign messages sent out, we have no control over that process. What will happen when a department agrees to send out messages for certain candidates but not for others? We have already received feedback that staff are willing to send out one or two messages, but they balk at sending out more than that. What if some candidates find their messages have been edited by staff, while others are sent out unaltered? We obviously have no recourse against UBC staff for this. I feel this has the potential to create the perception of a poorly regulated free-for-all. Therefore, I believe section 12.4.6 serves a very good purpose and should be retained. One last side note, AMS currently does not allow the candidates to distribute campaigning material via email lists administrated by the university, the society, faculty/department. I have talked to their Election Administrator and learnt that they have no plan to repeal this rule.

Thank you very much.

Teesha: I have a bit of experience with this at UVic GSS Council. A person was from a large department, used their email list, and won by a landslide, but we felt that it was a fairly unfair campaign as they were running against a candidate from a small department. And in my opinion it is important to have a fair grounds campaign. I am biased as I was closer to the gentleman from the small department, but I try to remove myself from this to see if this a fair way to campaign. I feel I would be on the side to not giving access as it is better to have even campaign grounds for voting.

Kate: I agree that coming from a large department can bias voters in favour of a candidate and using departmental email amplifies this. We need this is in our Policy Manual so it is more visible in the policy even if it is part of UBC's policy. If the motivation is to increase voter turnout then it makes more sense to ask all departmental reps to receive a general invitation to vote — in this way we can send a more uniform message. I am speaking against suspending this policy.

Alexa: Kate's point just covered mine. Individual campaigning is not a fair process, so maybe having a uniform "Go Vote" is the way to go.

Jun: The policy will stay there. The secondary intention is to start a conversation. The primary intention is to start something different like other grad societies or the AMS. The intention is suspension, not amendment or removal.

Arash: We are suspending part of the code which is against part of UBC code and adding something which is part ... If that is the case, I am against this motion and don't see need for this.

Theresa: Candidates can use other resources to send emails. To me this is an example of having access to something.
