#### DISCUSSION

**Natalie:** Hi, everyone. My name is Natalie. I'm really grateful to be here today and excited to be running as the next vice president External Relations. I'll give you a bit of a background about myself. I'm currently a master's student in indigenous community planning here at UBC. And I came to this field through my involvement in climate justice organizing. And this also brought me to where I am in student government today. So as I have learned through community organizing and climate justice, and through my graduate studies, collaboration between community groups and decision makers has the potential to yield change for a more equitable future. And I also firmly believe that these same principles can and should be applied to Student Government. And I've witnessed this success while serving as the external policy assistant with the GSS. Over the past year and a half. As the policy assistant, I've had the opportunity to lobby provincial and federal government leaders to improve support for graduate students. And just as one example of one of the successes we've had is the recommendation of the extension of BC graduate scholarships. And this actually ended up with the Ministry of advanced education promising \$3 million in extra funding for graduate scholarships. And I'm really proud of the success of my team and improving scholarship opportunities for graduate students. But I also know that our job is nowhere near complete. And that's because 1000s of students in BC have unmet financial need. And as a result, one of my goals, if I am to be elected is to increase needs based grant programs for bees for PC students. Right now, there are no needs based grants for graduate

students, they only exist for undergraduates. And that's a huge discrepancy. I also through my role have formulated relationships with students across the country and their graduate student organizations, and aim to work with them to advocate for students across the country. One of my other primary goals is to improve you UBCs response as well as all post secondary institutions responses to incidents of sexualized violence and really go for a Prevention's based approach right now, our, our, our strategy is far from adequate and I have some plans about how this can be achieved. So these are just a couple of my key points in my platform. I'm really hoping to be able to answer any of your questions, discuss any of the content that I have listed in my platform already. I'm really confident that I have this skill and the knowledge to serve as your VP external for the short term. But more importantly, and on a personal note, I really care about student issues. I am a student myself, and believe that graduate student, graduate education must be made more accessible to all. Thank you all for being or listening tonight.

**Ehsan:** My name is Ehsan Ferdosi, I'm originally from Iran, told myself applied sciences student here at University of British Columbia. And also, I'm a research assistant at structural engineering sustainable solutions, which is in Collaborate close collaboration with civil engineering and put science support department. To tell you a little bit about my background, I have experience of membership in a provincial Youth Council. So I'm totally very young society's needs and how to communicate on their behalf. I served as an advisor to the mayor of a 2 million people, Metro Police. So I know how government organizations work and how the police policymakers look toward the issues related to the youth society. And also I have experience of working with several teams in various fields, for example, in a 400, employee, company, and also lots of research teams, so I am totally aware of the key effect that teamwork can have. It's quite an honor for me to have the opportunity to serve as a VP in external affairs, I dreaming to make my presence known here at UBC. And I think it's the best there's no way better than doing it by make the graduate students to be heard and to stand by the grades.

**Sam:** And my question goes to both of you. Can you tell us how have you been involved with GSS? Up until this point, please?

**Ehsan:** My answer is not going to be that long. I'm actually I didn't have that much of a cooperation with GSS. I've heard about it. And I was really passionate to get involved with the organization. Actually, I tried to do that in the previous directory. That was my first step. But the busy schedule in courses and research didn't allow me to have justice.
